### About the PoNS<sup>™</sup> Device and PoNS Treatment<sup>™</sup>

The Portable Neuromodulation Stimulator (PoNS<sup>™</sup>) is authorized for sale in Canada as a class II, non-implantable, medical device intended as a short term treatment (14 weeks) of gait deficit due to mild and moderate symptoms from multiple sclerosis (MS), and chronic balance deficit due to mild-to-moderate traumatic brain injury (mmTBI) and is to be used in conjunction with physical therapy. The PoNS<sup>™</sup> is an investigational medical device in the United States, the European Union ("EU"), and Australia ("AUS"). The device is currently under review for clearance by the FDA. It is also under premarket review by the AUS Therapeutic Goods Administration. PoNS<sup>™</sup> is currently not commercially available in the United States, the European Union or Australia.
